CERTIFICATE E 220 / 2013

The Association of Architects (OA), created by Decree-Law 176/98 of 3 July, as the competent authority pursuant to Art. 15 of Decree-Law 14/90 of 8 January, which is in force under the terms of Art. 55.2 of Law no. 9/2009 of 4 March, which transposes Directive 2005/36/CE of 7 September to the Portuguese legal system, in conformity with Art. 42.1 of the Memorandum of the OA, which establishes that only architects enrolled in the Association can use, in the national territory, the professional title of architect and perform the acts proper to the profession, hereby certifies that:

- the architect Mariana Isabel da Silva Ramada Rocha Pires, born on 20 October 1982, a Portuguese citizen, enrolled in the OA on 9 January 2008, having been given the member number **16375**; this conferred the right to use the professional title of architect in Portugal;
- in the act of enrolment, the architect Mariana Isabel da Silva Ramada Rocha Pires, documented that she had successfully completed the Licenciatura em Arquitectura de Interiores at the Faculdade de Arquitectura da Universidade Técnica de Lisboa on 3 June 2006; such training is approved by the Portuguese State;
- no disciplinary proceedings of any kind have been initiated against the **Mariana Isabel da Silva Ramada Rocha Pires** for activities carried out in the scope of the profession of architect while a member of the OA.

This certificate was requested by the architect in question for the purpose of providing documental proof of his professional status with a view to practicing architecture in **Switzerland**. It is valid for a period of one year beginning on the date of issue and bears the embossed seal used by this Association.
